As per the Rules of the University, candidate admitted to Osmania Entrance, Pre-Degree Course & B.A.[Languages] courses most complete the course of study as duly registered candidate in double the duration of the course. They are however, eligible to appear for their backlog papers only on payment of Rs.1000/- per paper in addition to the normal Examination Fees, within next two (2) years immediately after the prescribed period of study (i.e double the duration of the course).
- 5. The Examination application forms of I,II & III year students admitted during the academic year 2010-11, 2011-12, 2012-13, 2013-2014 & 2014-2015 are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination branch duly signed by the Student and the principal concerned along with photocopy.
- 6. As a part of the Core Banking System, all the students are hereby instructed to deposit the examination fee into their respective college principal's accounts only (Students are advised **not to obtain** the DD in favour of 'the Controller of Examinations')

*** IMPORTANT NOTE:

- 1. All the College principals are requested to deposit (Credit)the consolidated examination fee amount into "Registrar, Osmania University Examination Fee Fund A/c No. 52198262033" in any branch of State Bank of Hyderabad and obtain a receipt from the bank and submit the same to the examination branch along with examination forms.
- (a) The students are advised to enclose the photo copies of their previous examination memorandum of marks duly attested by the college principal concerned along with the examination application forms.
- (b) Candidates who have applied for Revaluation/Recounting also have to pay the examination fee as per the above schedule without waiting for the results of Revaluation/Recounting as the case may be.
- (c) The candidates who are appearing for Improvement, must clearly and mention on their Application form as <u>FOR IMPROVEMENT</u> otherwise, their application forms will not be considered for Improvement as per the existing norms.
- (d) The Application forms not accompanied by the required Xerox copies of Memo of Marks attested by the concerned Principal of earlier Examinations are liable to be rejected. No Application will be accepted after 15-09-2015.
- (8) The Principals of the Colleges have to observe the following:-
- (i) Without late fee forms on or before 14-09-2015 and with a late fee

 Forms on or before 21-09-2015 have to be submitted in the Examination

 Branch, O.U. respectively, along with the Nominal Rolls and statement of
 Subject wise strength.
- (ii) The Principals have to instruct the concerned candidates to fill their Particulars in the Examination Application form(s) carefully, and get their Passport size photos duly attested by the concerned college Principal.
- (iii) A Penal Fee of Rs.1000=00 per day shall be levied if the college fails to submit the examination application forms(s) with in the stipulated Date mentioned above.

Note: THE PRINCIPALS ARE REQUESTED NOT TO SUBMIT EXAMINATION APPLICATION FORMS OF NOT ELIGIBLE CANDIDATES.

FURTHER, IT IS CLARIFIED THAT THE RESULTS OF SUCH CANDIDATES WHO ARE NOT ELIGIBLE TO APPEAR FOR THE EXAMINATIONS WILL BE CANCELLED AT ANY STAGE.
