1. The selection of the candidates is strictly provisional subject to the production/verification of the original documents/valid category certificate(s) wherever applicable. In case of any discrepancy found at any point of time, the University reserves the right to cancel/modify such selection/admission forthwith.
2. The above mentioned provisionally selected candidates are advised to deposit their requisite fee as mentioned in the University Prospectus through any of the following modes w.e.f. **30<sup>th</sup> of September to 4<sup>th</sup> of October 2016:**
  - a) By online payment mode through the University website [www.islamicuniversity.edu.in](http://www.islamicuniversity.edu.in).
  - b) By generating the pay-in-slip from the university website and depositing the requisite fee at any branch of J&K Bank.
  - c) By depositing the total fee of first semester as mentioned in the University Prospectus in cash at admission Counter of IUST temporarily functional at J&K Institute of Mathematical Sciences, Amar Singh College, Gogji Bagh Srinagar. **(Operational only on 3<sup>rd</sup> & 4<sup>th</sup> of October, 2016).**
3. Those candidates who have already deposited their Caution Fee and stands selected under **General/Reserved** Category (ies) in this Notification need only to download their Admission Letters from the University Website.
4. Those candidates who have already deposited their Caution Fee and stands selected under **SF** Category in this Notification are advised to deposit the remaining amount as mentioned in the University Prospectus through any of the modes mentioned above at (2) w.e.f. **30<sup>th</sup> of September to 02<sup>nd</sup> of October 2016**, for the confirmation of their admission, failing which it shall be presumed that they are not interested in Admission under **SF** Category and the seat shall be allotted to the next candidate as per the merit and preference accordingly.
5. The candidates having **SINGLE ASTERISK MARK (\*)** superscribed on their Form Numbers are already admitted candidates and have been upgraded from one branch to another in view of their merit and preference. Such candidates are informed to download their updated Admission Letter from the University Website.
6. The candidates having **DOUBLE ASTERISK MARK (\*\*)** superscribed on their Form Numbers are advised to report in writing at Admission Counter of IUST temporarily functional at J&K Institute of Mathematical Sciences, Amar Singh College, Gogji Bagh Srinagar, for the final allocation of their branches on **3<sup>rd</sup> or 4<sup>th</sup> of October, 2016**, failing which it shall be presumed that the candidate(s) are interested in the already registered branch.
7. The candidates having **TRIPLE ASTERISK MARK (\*\*\*)** superscribed on their Form Numbers may note that they have been upgraded from Self-Financing category to General Category in the already allotted branch in view of their merit and preference.
8. In case of any resultant vacancies after **4<sup>th</sup> of October, 2016**, further upgradation shall be done on the basis of Merit & Preference amongst the **already admitted candidates only**.
9. **In case of any resultant vacancy (ies) after the upgradation of admitted students, further selection shall be done on the basis of Counselling to be notified separately.**
