At the very outset the Director, Directorate of Sports & Physical Education, University of Jammu welcomed all the Physical Directors, PTIs, Incharge Teachers of the different colleges attending the meeting and thereafter the items of the agenda were taken up one by one.

ITEM - I: To confirm the minutes of the Last meeting

Resolved that the minutes of the last meeting held on 28/05/2015 at 11.30 a.m. in the office of the Director, Directorate of Sports and Physical Education, University of Jammu be confirmed.

ITEM-2: To discuss the dates of the Annual Calendar of the Inter-Collegiate Tournaments / Competitions 2016-17.

Resolved that the Inter-Collegiate Tournaments / Competitions be conducted on the dates proposed by Director, Directorate of Sports and Physical Education, University of Jammu with small changes suggested by the Physical Directors/PTI's/Incharge teacher's of Sports

who attended the said meeting. The approved calendar of activities is attached herewith for reference please.

ITEM – 3: To Discuss the Dates for the conduct of the Inter-Collegiate Annual Athletic Meet 2016-17.

It was unanimously Resolved that the February 15th, 16th and 17th 2017 be fixed tentatively for conduct of the Inter-Collegiate Annual Athletic Meet.

ITEM – 4: To discuss the matter regarding the late submission of the TA/DA bills of the players / officials, incomplete eligibility profarma / Identity Card by the College concerned official, non availability of teams managers and Uniforms of the teams:-

a) Submission of Bills within 20 days after completion of the Inter Collegiate Tournaments

Resolved that all the TA/DA bills shall be submitted in the office of the Director, Directorate of Sports & Physical Education, University of Jammu by all the Physical Directors, PTIs, Incharge Teachers through the concerned Principals within 20 days after the completion of the Inter—Collegiate event, game / competition. No bill shall be accepted after the expiry of 20 days after the completion of individual game, event or a competition. The Physical Director, PTI or Incharge teacher of the participating college shall be responsible for any type of delay in submission of the bills and Director, Directorate of Sports and Physical Education will not accept any bill after the expiry of given time period.

Resolved that the Eligibility proforma shall be submitted on the analogy of AIU norms i.e. the photographs of the players must be affixed on the eligibility proforma and must be duly attested by the Head of the Institution i.e., Principal, Rector or Director Campuses failing which the player will not be allow to participate in any event, game or competition.

b) The matter regarding mistakes in spellings of names of the player, Father's name or Mother's name have been creating problems for the participating players and Director, Directorate of Sports and Physical Education as well.

Hence, It was **Resolved** that the Eligibility profarma of individual player or team must be submitted in typed form in order to avoid the spelling mistakes in the eligibility form. It was further Resolved that no duplicate or additional certificate shall be issued to the player in addition to the original certificate and concerned Physical Director, PTI or Incharge Teacher shall be responsible for the spelling mistakes or misplacement of the certificates.

c) The Director, Directorate of Sports and Physical Education, has been facing a lot of problems due to the non accompanying of the team managers of affiliated colleges for identification of the players responsibility of indiscipline to be created by any of the participants, injuries received by the participating players and so on.

Therefore it was Resolved that no player / team shall be allowed to participate in any game, event or competition without the team manager i.e. Director Sports, PTI or Incharge teacher of the concerned college or campus. The proper authorization or deputation signed by the Principal of the concerned college shall be the mandatory condition for the Physical Director, I/c PTI, or Teacher Incharge from the concerned College.

d) It has been observed that after number of requests, rectifying steps, cautions and warnings colleges are deputing their teams /players for participation in Inter-Collegiate competition without proper uniforms.



It was unanimously Resolved that no team / player of any government or private Colleges affiliated to the University of Jammu shall be allowed to participate in any game or event without a proper uniform. The College which would not adhered to the above instructions, their team / player could be debar from participating in tournaments to be organized by the Directorate of Sports and Physical Education, for the period to be decided by the committee headed by the Director, Directorate of Sports and Physical Education, University of Jammu.

ITEM - 5: Any other Item/s with the permission of Chair

e) A query was raised by the Director Sports, Women College Gandhi Nagar regarding the non participation of team/s after submitting the entries. He was of the opinion that some penalty must imposed on such colleges or teams who does not participate or does not even intimate the office of the Director, Directorate of Sports and Physical Education on time after submitting the entry of the team or players. Later on he was joined by many other including Director Physical Education, GDC Paloura, Director Physical Education, Govt. B.Ed College, Director Physical Education, Women College Parade and so on.

It was **Resolved** that in case a College is unable to constitute a team or project its player for participation after submitting the eligibility, the concerned college must informed the office of the Director, Directorate of Sports and Physical Education, University of Jammu at least two days before the conduct of the tournament/event, failing which a penalty in shape of debarring the college for participation in the Inter-Collegiate competition or financial penalty will be imposed to the tune and period as decided by the committee headed by the Director, Directorate of Sports and Physical Education, University of Jammu.

f) Assistant PTI, Degree College Poonch raised the point regarding providing of accommodation to the out stationed teams of the muffasil colleges during the Inter-Collegiate competition.

The Director, Directorate of Sports and Physical Education, University of Jammu showed his inability to provide accommodation to the out stationed teams until and unless the sports hostel under construction is not completed. However, it was Resolved that unfurnished accommodation without bedding can be provide to 5 to 6 teams if they are willing to stay in the accommodation available with the Directorate of Sports and Physical Education with very little facilities and odd conditions.
