Notification

It is hereby notified for the information of all concerned that the admission to Semester-I of the **Three Year (six Semesters) B.A./B.Sc./B.Com. (General) /B.B.A./B.C.A Course** for the year 2016 in Degree Colleges affiliated to the University of Jammu falling under Winter Zone shall be made as under

- a. 29-02-2016 to 19-03-2016 (without any late fee)
- b. 20-03-2016 to 29-03-2016 (with a late fee of Rs. 220/-)
- c. The Vice Chancellor may consider grant of late admission for 10 days only after the expiry of last date as per (b) above on payment of Rs 1980/- as late fee.

The regular teaching work shall begin with effect from 2nd week of April onwards.

ELIGIBILITY CRITERIA FOR Admission to B.A./B.SC./B.COM SEMESTER-I

Admission to Semester First of the Three Year B.A./B.Sc./B.Com.(General) Course shall be open to a person having passed the Higher Secondary Part-II (10+2 pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education or an examination recognized as equivalent thereto subject to availability of seats & if otherwise found eligible. However, a candidate who is placed under re-appear category only in one subject in Hr. Secondary Part-II (10+2 pattern) shall also be eligible to seek **provisional admission** in Govt. Colleges opened in 2005 and onwards on his/her own risk and responsibility, **subject to clearance of backlog within the prescribed chances.**

ELIGIBILITY CRITERIA FOR ADMISSION TO B.B.A. COURSE SEMESTER-I

Admission to Semester-First of the Three Year B.B.A. shall be open to a person having passed the Higher Secondary Part-II (10+2 pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education or an examination recognized as equivalent thereto and has obtained at least 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates.

ELIGIBILITY CRITERIA FOR ADMISSION TO B.C.A. COURSE SEMESTER-I

Admission to Semester-I of the Three Year B.C.A. shall be open to a person having passed the Higher Secondary Part-II (10+2 Pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education or an examination recognized as equivalent thereto with Mathematics as one of the elective subjects and has obtained at least 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates.

Note:-

1. The admission in the Govt. Degree Colleges affiliated to the University of Jammu shall be made directly by the Admission Committee of the college concerned on the basis of marks obtained by the candidates in the qualifying examination & strictly as per other Statutes.
2. Candidates desirous of seeking admission in the Non Govt. Colleges falling in Winter Zone for B.B.A/B.C.A Courses are advised to refer to the University **Website** (www.jammuuniversity.in/www.jucdc.in)
