For constituting the Panel of Examiners for conduct of B.Ed practical  
examinations, the following qualification and experience has to be considered according  
to the Bangalore University B.Ed Regulation 10.1 & 10.2 for appointment of:

Internal Examiners	:	M.Ed with minimum of 3 year teaching experience in B.Ed college
External Examiners	:	High School Headmasters/ Senior teachers with minimum 10 year teaching experience

The following documents are to be furnished for the approved time table and List of Examination

To obtain approval, please furnish the following:

- a. Panel of Examiners indicating their qualification, experience by obtaining their signatures (proforma enclosed).
- b. List of schools identified for conducting practical examinations with exact address and phone numbers of the schools & Principals. The schools identified by the college have to be within & 10 kms from the colleges.
- c. Copy of the students' admission approval by Bangalore University, Bangalore.
- d. Copy of Faculty approval of your college by Bangalore University, Bangalore.
- e. Certificate of teaching experience for internal & external examiners from the concerned authorities and their acceptance letters to work as Examiners.
- f. Copy of Time-table, mentioning the name of the school and address.
- g. Minimum lessons per day is 04 lessons and maximum should not be more than 05 lessons.
- h. The students are expected to be present in the school from the 1<sup>st</sup> hour of the examination and stay back up completion of the examination, until all the students have finished giving their lessons.
- i. Students must carry their college ID card for identification.
- j. Each student should give 2 lessons in their respective subjects in two different boards on two different dates.
- k. Four copies of the documents mentioned above have to be submitted to the chairperson at the time of approval.
- l. The last date for getting approval of panel of examiners and time-table is **16.11.2015**.
- m. The colleges should intimate the school Headmaster/Headmistress to maintain day to day attendance register of the students taking up the examination and it will be verified by the Bangalore University Squad members.
- n. The Principals are hereby requested to furnish all the details duly signed by him/her for approval. If any alteration in the time-table(after obtaining the approval, the same has to be brought to the notice of the Chairperson.
- o. The filled in Marks List of the Practical Examination should be sent to Registrar(Evaluation), Jnana Bharathi, Pariksha Bhavan, Bangalore-56 (B.Ed Marks card Section) in Sealed Covers on the same day of the Examination without fail.
