Norms for admission to the B.A. LL.B. (Hons.) Degree Programme, 2016-17, under the NRI Category

- NRI seats are applicable to such candidates whose parents (both or either of them) are residing outside India for the purpose of employment. The number of seats available for NRI candidates is 12 (twelve). If sufficient candidates are not available under the NRI quota, such vacant seats shall be filled from the All India General Category candidates in the order of CLAT 2016 merit.
- 2. The candidates under this category should have passed an examination recognized by the Association of Indian Universities (AIU), New Delhi, as equivalent to Higher Secondary Examination (10+2) under Indian System, securing not less than 45 % marks in the aggregate.
- 3. The candidate must have studied English language as one of the compulsory subjects in 10+2 or equivalent Higher Secondary School Examination.
- 4. Candidates who seek admission under the NRI Quota are exempted from taking CLAT 2016.
- 5. The admission will be made strictly on the basis of inter se merit in their 10+2 examination or an equivalent examination.
- 6. The following documents should be enclosed with the filled in Application Form:
 - a. Copy of the statement of marks in the Qualifying Examination (i.e. an examination equivalent to 10+2) recognised by the Association of Indian Universities (AIU), New Delhi;
 - b. Percentage Conversion Certificate from the School/Board, in case of Grades (if applicable);
 - c. Copy of the Birth Certificate;
 - d. Copies of the Passports of the parent and the candidate
 - e. Certificate from the Indian Embassy of the respective Country to prove that the parent/s is/are NRI
 - f. Demand Draft for Rs. 5,000/- drawn in favour of 'THE REGISTRAR, THE NATIONAL UNIVERSITY OF ADVANCED LEGAL STUDIES' payable at Kochi/Ernakulam
